Continuing Education for CPCUs

Editor's Note: The FGC Chapter thanks the Iowa CPCU Society Chapter for this article.

Starting July 1, 2016 CPCUs may begin earning credits that count toward the CE for CPCUs program. Although The Institutes does not have a specific date yet, CPCUs will be able to begin reporting their credit hours sometime during the second half of 2016, when the reporting platform becomes available.

Based on a survey conducted last year, current CPCUs and CPCU students overwhelmingly indicated that they felt a formalized reporting of continuing education would increase the overall value of the CPCU designation.

Goals of the program include allowing CPCUs to select educational activities that are most relevant to them as well as elevating the overall experience within the CPCU Society.
